# Information sheet for requesting a Geneva Convention passport

#### **Requirements**

- Persons who are entitled to be granted asylum in Austria ("Positive decision/finding under § 3 AsylG [Asylum Act] 2005").
- In certain cases, persons who are entitled to be granted asylum in a different country and who have settled in Austria.
- Making an appointment: If possible, make an appointment online using your smartphone or PC. Link: <a href="https://citizen.bmi.gv.at/at.gv.bmi.fnsetvweb-p/etv/public/bfa/Terminvereinbarung">https://citizen.bmi.gv.at/at.gv.bmi.fnsetvweb-p/etv/public/bfa/Terminvereinbarung</a> (appointments can be booked throughout Austria).
  "Please make a separate appointment for each person!"
- If you cannot make an appointment online, appointments can be booked by phone in exceptional cases. (Link: <a href="https://www.bfa.gv.at/Kontakt/start.aspx">https://www.bfa.gv.at/Kontakt/start.aspx</a>).
- You must appear in person for your appointment. (All applicants including minors)
- Applications are only filed with the authorities on the day of the appointment.
- Bring and present all documents as originals or certified copies.

### **Required documents**

- **1 current passport photo** (portrait format, 35 x 45 mm) in color (EU photo); specifications: https://www.bmi.gv.at/607/Passbild Kriterien.aspx
- Official photo identification; if not available, the following can also be used:
  - o Identity documents from your country of origin
  - o Identity witness who has their own official photo identification
  - o If no proofs of identity are available, your identity can be checked by the authorities when you present the asylum decision.
  - o For children born in Austria, a birth certificate
- **Documents indicating civil status,** where available (birth certificate, marriage certificate, partnership document). In the case of name changes, these are always required.
- Positive asylum decision (decision to grant asylum entitlement)
- Where applicable, an earlier Geneva Convention passport (this will be invalidated) or loss/theft report
- Where applicable, documentary evidence of an academic degree or the professional title of Engineer

In individual cases, the passport office may request additional documents – especially if they have doubts as to whether the data is correct (e.g. spelling).

#### **Additional documents for minors**

- Identity document of the acting parent or statutory representative
- Proof of custody where this is not on file for the parents (e.g. child's birth certificate and parents' marriage certificate).

### **Fees**

- €112.00 (issuing fee) in cash for applicants age 12 and up
- €44.00 for children under the age of 12
- 1<sup>st</sup> passport for children under the age of 2 is free of charge, valid for a maximum of 2 years.

Note: We do not accept €200.00 or €500.00 bills as payment.

### **Scope and validity**

The Geneva Convention passport is valid in every country in the world with the exception of your country of origin, and is <u>fundamentally valid for 5 years</u>.

As we have extended our office hours, it is not necessary to arrive at the office before opening hours.
